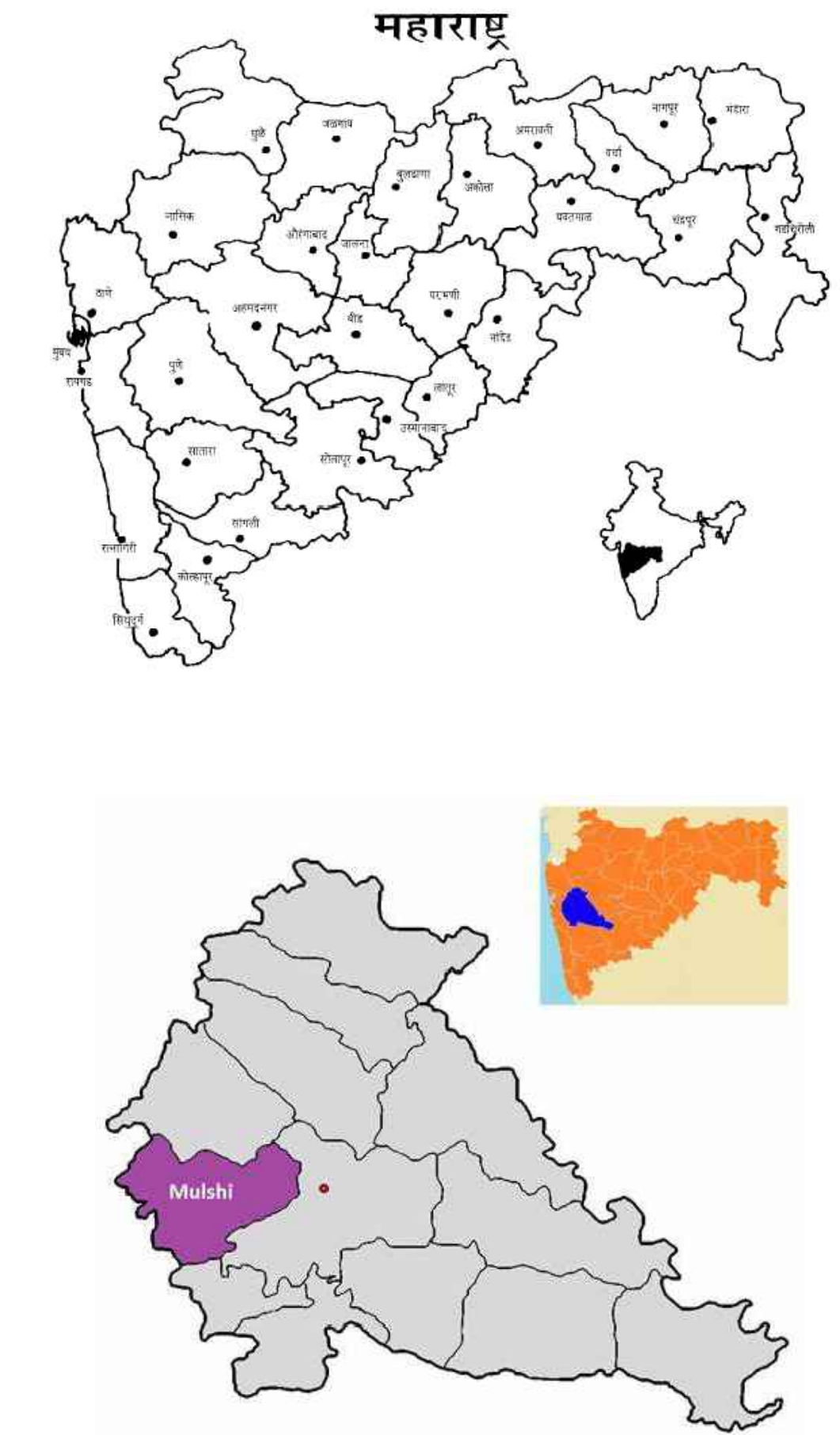
PLAN No. - 3 SHOWING ORIGINAL PLOTS & FINAL PLOTS

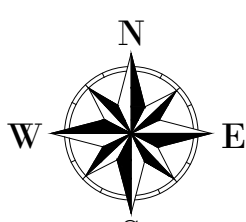
